Announcing Members' Day: The Middle East

Members' Day is a new initiative of DCFR and seeks to create an opportunity for members and guests to engage with a range of experts on a single theme during a single event. The Members' Day theme for this year's event will focus on the situation in the Middle East. The event is being organized with the cooperation of the Israel Public Diplomacy Forum, a non-profit, non-partisan, educational organization that seeks to advance international understanding of Israel and the Middle East by generating dialogue based on informed and reliable information.

In order to ensure members are able to engage with the speakers and panelists to the fullest possible extent, we are imposing time limits. The panelists will speak for 10 minutes each, and the speakers for 30, leaving time for audience participation.

LUNCH SPEAKER: We will begin at lunch with a presentation by Roger Harrison who was appointed by President

the Gulf war began. He is presently the founding director of the Eisenhower Center for Space and Defense Studies at the Air Force Academy.

PANEL ONE: Following the lunch speaker, a panel will assess the Obama Administration's Foreign Policy. The participants will include: DCFR's Dr. Paul Viotti, Ambassador Roger Harrison, University (Denver) Professor Tom Farer and others.

AFTERNOON SPEAKER: Our afternoon speaker, Dr. Ely Karmon, will discuss "Countering Terrorism." Dr. Karmon is a Senior Research Scholar, International Insti-

tute for Counter-Terrorism (ICT).

PANEL TWO: Our second panel will focus specifically on assessing U.S. Policy in the Middle East. Participants will include Korbel's Professor David Goldfisher, Ambassador Roger Harrison, and two others.

DINNER SPEAKER: Professor Eytan Gilboa will conclude the event with a presentation on, "The Changing Middle East." Dr. Gilboa is the Founding Director, School of Communication, Bar-Ilan University, Israel; He is also Director, Center for International Communication and Senior Research Associate, BESA Center for Strategic Studies.

This will be an outstanding opportunity to engage with experts about the Middle East, a region that is of great concern to all, and to do so in a stimulating environment. So, be sure to mark the afternoon of Nov. 5th on your calendars and by all means bring along one or more guests who will be charged a modest \$75 to cover the costs of the lunch, reception, and dinner.

Outreach Update: World Affairs Challenge

The World Affairs Challenge (WAC) is a program dedicated to developing tomorrow’s global leaders. Through ongoing mentoring, education, and competition, WAC identifies middle-school and high-school students who are passionate about world affairs and helps engage them in developing solutions to the world’s most pressing problems.

WAC’s centerpiece is its annual one-day competition held each spring. The DCFR collaborates with the Center for Teaching International Relations (CTIR) to provide participation grants to rural Colorado schools for the exciting annual event.

The 2016 Theme *Smart Villages*

Location: Regis University
Date (high-school): March 5th
Date (middle-school): April 9th

For *Smart Villages*, students will examine how remote, often off-grid, communities are integrating the basic necessities of life - water, agriculture, energy, sanitation, health, and education - to enhance the lives of some two billion inhabitants on Earth.

In 2017, the theme will be *Smart Cities* and in 2018, students will link these themes to craft a *Smart Planet!*

WAC is more than a one-day event. Students are mentored by individuals, businesses, and non-profit organizations in the community to foster their understanding of global issues and opportunities. And following the competition, students are connected to a network of universities and organizations where they can continue their development into global thinkers, doers, and leaders.
